You are welcome to send a replacement dancer in your place should you not be able to attend, on condition that you inform Goddess Divine Productions with the details of the replacement. No replacement certificate will be offered. In the unlikely event that you are unhappy with your first workshop, you may not cancel the remainder workshops that you have booked for. Replacements may not be sent for any Discounted / Special packages booked.
3. **Disclaimer:** We reserve the right to use substitute teachers of similar caliber in the case of unavoidable illness or injury and may vary advertised workshop programs should the need arise.
